## Nurses Working Group-Pre-Conference Meeting

The APPHON Nursing Working Group met on Thursday April 26, 2007, 1300-1630 in the Parker Reception Room of the IWK Health Centre. The document, "Practice Standards and Competencies for Nurses Providing Cancer Care to Children with Cancer and their Families in Atlantic Canada," was complete and the group met to plan the next step - implementation of the document. Discussion included how APPHON can help nurses use the document, who needs to have the document and how should they get it, and how we make the education happen [just-in-time pieces, basic knowledge and skills, what's in place now, and gaps, difficulties /obstacles?].

The following plan was developed:

- Nurses within the APPHON Nurses Working Group will be given a copy of the document with the recommendation of using it for personal professional development by using the self assessment tool to help them identify their learning needs [and thus helping to trial it], with an explanation of the planned process for implementation. In the future, the document will be appended to the Levels of Care document and be introduced as a part of the implementation of levels of care. For the centres and districts that have

had initial visits, the document will be included and introduced in an upcoming APPHON update mail out to nurse/unit managers [It was concluded that nurse/unit managers responsible for their nurses' competencies, could initiate discussion with those who have a say in budgets and resources, and with those could best determine how it be used and introduced to staff nurses].

- It was agreed that APPHON should recommend "The Pediatric Chemotherapy and Biotherapy Curriculum" be taken by any nurse administering pediatric chemotherapy in the Atlantic Provinces. Kim Chapman will take this to the board and advocate for financial assistance for the tertiary centres to offer the course. This recommendation is not doable unless this course can be provided to nurses in the Atlantic Provinces.
- Work will continue to be done to implement the competency document and provide the education resources that would allow nurses to achieve and maintain the competencies. With the technology available today, perhaps more needs to be done with videoconferencing and website education.

The workshop ended with a presentation by Mary Jean Howitt, adapted from the "The Pediatric Chemotherapy and Biotherapy Curriculum," on Biotherapy.

## Psychosocial Working Group

The psychosocial working group held a meeting on April 26<sup>th</sup>, 2007 before the annual APPHON conference. The committee has a couple of projects on the table at the present time. One of the projects presently being worked on is the development of a resource list. This resource list will hopefully encompass

the names and contact numbers of all psychosocial professionals within the Atlantic Provinces.

The second project on the table for the psychosocial committee is the completion of the Distress Management Guidelines. The Delphi was examined at the meeting and the ratings helped to shape the proposed contents of the guideline. It is the hope of the psychosocial committee that they can find existing information that is evidence based. The areas of the proposed guideline were divided into sections and the responsibility divided amongst the members of the psychosocial committee. The group is presently off and running on the guideline.

The working group has a busy and exciting year ahead of them, and we look forward to keeping you updated on our progress.
